## CONSIGNMENT AGREEMENT

Consignee: Imperator Products LLC

Consignor: Firearm/item owner

Consignor agrees to place item(s) listed on consignment under the terms of this agreement.

Consignee agrees to accept the item(s) listed for consignment under the terms of this agreement.

Consignee agrees to the following:

- Inspect item(s) listed to determine condition and functionality.
- Write up description and specification necessary to offer item(s) for sale.
- Maintain and insure item(s) for the net amount stated in agreement.
- Offer item(s) for sale as it deems appropriate.

Consignee reserves the right not to display or list for sale any item(s) found to be defective. Any such item(s) must be reclaimed within 15 days of mailing notification. Item(s) not reclaimed within 15 days of mailing notification will become property of Imperator Products LLC.

When item(s) consigned is/are sold and final payment is made by the buyer, Consignor will receive net amount within 30 days. If Consignor cannot be contacted within 15 days of sale, a check will be sent to the address provided.

Consignor agrees to the following:

- They are the rightful owner of item(s) listed and item(s) is/are free of any encumbrance.
- While this agreement is in effect, Consignor agrees to grant Consignee exclusive right to market and sell the item(s) listed.
- Item(s) listed in an online auction may not be reclaimed unless circumstances meet the requirements of the auction site.
- Item(s) consigned will be consigned for a minimum of 60 days. If item(s) is/are not sold within 60 days Consignor must pick up firearm or renew agreement in person within 15 days. After 15 days a storage fee will be assessed at \$5 per day. If item(s) is/are not picked up within 30 days after agreement expires, the item(s) becomes property of Imperator Products LLC.

If Consignor decides to have item(s) returned, Federal Law requires Consignor complete all appropriate forms and pass a NICS background check as if they were purchasing the firearm(s).

If Consignee fails to pass ATF Form 4473 or NICS background check, they will have 10 days to solve the issue. If the issue cannot be resolved the firearm(s) will become the property of Imperator Products LLC.

Consignment fee is \$50 or 10% of sale price if over \$500.

LIABILITY:

Consignee shall not be liable to Consignor for any loss or damage suffered to Consignor's merchandise, including, but limited to, loss or damage to such merchandise from fire, theft, or other casualty. Consignor hereby releases Consignee to the fullest extent possible under the law from any and all claims or any nature in connection with or arising from the placement of Consignor's merchandise with Consignee. Consignor further covenants that he/she shall make no claim against Consignee, Consignee's insurance carrier or the property owner where the items are being stored or held for any damage to Consignor's merchandise.
